This Agreement made between Customized Logistics Group, LLC, doing business as (DBA) "Professional Drivers©, referred to herein together with its parents, subsidiaries, affiliates, representatives, employees, agents, subcontractors and officers-collectively, as "Professional Drivers© or "Driver", "Agent", "we", "our" or "us", 1836 W. "Owner" refers to any person that has the legal or rightful title to the Vehicle. "Authorized Agent" refers to any person employed by the Vehicle's Owner/Authorized Agent or business requesting our service in the moving the Vehicle. "Rider" refers to any person that has the legal or authorized duty in ride along in the Vehicle with Driver/Agent. "Individual" refers to anyone who enters into an Agreement to use the services of Professional Drivers. "Sole Discretion" means the only person with the freedom to decide how to act or what should be done in particular situation. "Vehicle" is the vehicle that is equipped and licensed for use on public roads.

INSURANCE INFORMATION

The undersigned Owner/Authorized Agent states that Professional Drivers and its Drivers/Agents have the expressed and implied consent to operate said Vehicle.

The undersigned Owner/Authorized Agent certifies and guarantees that the Vehicle to be driven is covered currently by liability insurance in the minimum amount of **\$100,000-\$300,000** along **WITH FULL COMPREHENSIVE AND COLLISION INSURANCE**. The insurance will be in **FULL FORCE** at all times while the Vehicle is in the possession of Professional Drivers. It is further understood that the Vehicle owner's insurance is the primary insurance for the Vehicle (**We recommend you check with your insurance company to make sure this is the case with your policy**). On request Professional Drivers will provide the Driver/Agent's name and license number to be added to YOUR POLICY. Professional Drivers will NOT be liable for any damages to the Vehicle or any injuries caused by Professional Drivers and/or its Driver/Agent, to the fullest extent permitted by law.

SAFETY FIRST

Professional Drivers **WILL NOT** move or operate any Vehicle under unsafe operating conditions. Vehicles will be considered unsafe by our Driver/Agent if they determine any mechanical issue exist in their Sole Discretion. The Vehicle must be properly registered for our Driver/Agent to operate the Vehicle. At the time of pickup, our Driver/Agent will inspect the Vehicle to determine if the Vehicle is registered and insured. The Owner/Authorized Agent will be charged a fee of \$_____ plus all expenses incurred in returning our Driver/Agent to his/her home base, including transportation costs, any airline change fees, ground transportation, food and motel accommodations, if it is determined by Professional Drivers in their Sole Discretion, whether the Vehicle is in an unsafe operating condition, not properly registered or properly insured. Professional Drivers assures that our Driver/Agents have proper driver's license and the right to drive.

Weather and mechanical delays will be charged at the rate of \$_____ per day plus all expenses including overnight accommodations and food. Related expenses such as airline change fees, increased airline transportation cost, parking and ground transportation costs are the sole responsibility of the Owner/Authorized Agent.

In the event of weather delays, Professional Drivers will determine in their Sole Discretion of our Driver/Agent if the roads are safe to operate the Vehicle.

In the event of a major mechanical breakdown our Driver/Agent will make every attempt to have the Vehicle towed to a manufacture's garage or to the garage of the Owner/Authorized Agent request. If the unlikely event were to occur and Professional Drivers along with Owner/Authorized Agent may have to leave the Vehicle while repairs are being made, our Driver/Agent, in consultation with the Owner/Authorized Agent, together will determine the best course of action. It is expressly understood the Owner/Authorized Agent is responsible for the authorization and payment of ALL repairs to the Vehicle. In addition, all transportation expense costs will be assumed by the Owner/Authorized Agent to and from the Vehicle from which the Vehicle has repairs performed. If for any reason the Owner/Authorized Agent does not want Professional Drivers to return to the Vehicle to complete the trip, the Owner/Authorized Agent will be responsible for paying Professional Drivers the entire contracted price plus all incurred expenses including transportation, food, overnight accommodations and ground transportations costs associated with the return of our Driver/Agent to his/her home base. The Owner/Authorized Agent will hold Professional Drivers harmless for any event relating to the Vehicle and its repairs.

In the event of minor mechanical breakdown Professional Drivers will consult with the Owner/Authorized Agent and try to assist, if asked, in the matter(s) immediately and resume travel as quickly as possible. It is expressly understood the Owner/Authorized Agent is responsible for the authorization and payment of ALL repairs including without limitation minor repairs such as wipers, fluids, lights, belts, and tires. The Owner/Authorized Agent understands even minor repairs may incur delays and any additional expenses as outlined in the above paragraph may apply.

FEES (NON-REFUNDABLE)

Professional Drivers and the undersigned Owner/Authorized Agent agree to the following charges:

ALL TRIPS REQUIRE A NON-REFUNDABLE DEPOSIT OF AT LEAST 50% OF THE BASE FEE

\$_____ Per Day. There is a minimum of a one (1) day charge. The rest of the trip will be billed in half day increments using the daily rate. The Rider will be responsible to pay at the time of occurrence all charges for food, fuel, tolls, parking, hotel accommodations and any other trip incidentals. Our transportation cost to and from the Vehicle will be pre-paid by the Owner/Authorized Agent along with the 50% non-refundable deposit. If prepayment of your trip is required your credit card will be charged for the full amount of the trip plus all known expenses and anticipated fuel, tolls and transportation charges. Cancellation fees will also apply. Vehicles will have nothing in tow unless the box is checked: Towed trailers are to be safe for towing and property registered. Issues with towed trailers will be treated the same as with the Vehicle as set forth in this agreement.

WAITING FEES

All Vehicles must be ready and fully loaded at the agreed upon time of pickup. Any Vehicle that is not ready at the agreed upon time will be subject to a waiting fee charge of \$_____ per hour plus all expenses incurred. If for any reason waiting time exceeds 4 hours, it is expressly understood the trip may be canceled by Professional Drivers at our Sole Discretion. If the trip is canceled the Vehicle's Owner/Authorized Agent will be responsible for one (1) full day of service including all expenses and return transportation of the Driver/Agent. If the trip is postponed (not canceled), the Vehicle's Owner/Authorized Agent will be responsible for at least one day of service and all additional expenses such as, but not limited to, airline change fees, food, overnight accommodations and ground transportation. The one-day service fee is \$_____ including all incurred expenses.

CANCELLING OR RESCHEDULING YOUR VEHICLE DELIVERY

All deposits are non-refundable

An additional cancellation fee of \$_____ will be assessed along with any deposits collected including all expenses already incurred by Professional Drivers including, but not limited to, airfares and ground transportation currently booked. However, your deposit may be applied towards any future trips for up to one year from the date of cancellation. All airfares are subject to the airlines rules and regulations. If new airfare must be purchased, the Owner/Authorized Agent is solely responsible for fees.

* Once a Driver/Agent has been assigned to work for you, he/she is affectively excluded from other jobs that may arise, and without this fee he/she is essential taken out of the work pool.

VEHICLE DELIVERY PAYMENT

Payment in full is required at time of delivery and may be made in Cash, Certified Check, American Express, Visa, MasterCard, or Discover. **Gratuities are not included in our pricing and may be added at your discretion.**

WAIVER OF SEARCH AND SEIZURE RIGHTS

As a policy, if Professional Drivers, its Drivers/Agent, is stopped by either a Federal, State or local law enforcement official, Owner/Authorized Agent agrees to allow the Vehicle transported by our Driver/Agent to be searched by said officials upon request without requiring said official to have either probable cause or obtain a search warrant. The Owner/Authorized Agent/Rider of the Vehicle being transported specifically and expressly waives all objections to a voluntary search of said Vehicle. You further acknowledge you indemnify and hold Professional Drivers and its Driver/Agent harmless for all violations of Federal, State and/or local law should any contents of the Vehicle violate any such law, excluding the contents of Professional Drivers, its Drivers, employees, Agents or subcontractors. By signing below, you acknowledge you are aware you may have State or Federal Constitutional rights against search and seizure. However, you are waiving said rights should Professional Drivers be stopped by law enforcement while in possession of your Vehicle.

COLLECTION COSTS

Our services are payable upon completion of the trip. It is clearly understood your account will be deemed overdue if unpaid more than 15 days after the invoice due date. If for any reason Professional Drivers incurs any costs in collecting all monies due and owed for services rendered, we retain the right to collect and recover all costs and fees including attorney's fees related to such action. To the fullest extent of the law, the Owner/Authorized Agent/Rider agrees to an interest charge of 18% APR per month plus late payment fees on all outstanding balances.

It is the intention of the parties hereto to strictly comply with and conform to all applicable law, including usury laws. Accordingly, all agreements between the parties to this Agreement are expressly limited so that in no event whatsoever will the amount paid or agreed to be paid to Professional Drivers exceed the highest lawful rate permissible under applicable usury laws.

INDEMNIFICATION AND ADVANCEMENT OF EXPENSES

The above named Owner/Authorized Agent/Rider or business agrees to indemnify and hold harmless Professional Drivers and/or any Driver/Agent of Professional Drivers acting within the scope of their job, from any acts of God, negligence or harm occurring while Vehicle is in the possession of Professional Drivers for the purposes described above, excluding the negligence, gross negligence, intentional or criminal misconduct, and/or any deviation of Professional Drivers or its Driver/Agent outside the scope of this Agreement.

In addition, the above-named Owner/Authorized Agent/Rider or business agrees to pay Professional Drivers in advance of the final disposition of any Proceedings ALL expenses incurred by Professional Drivers in defending any such Proceeding.
