## Pet Transportation Addendum

\_\_\_\_\_ **Professional Drivers is a company business in the transportation of vehicles and not a company business in the transportation of pets.** (please initial to acknowledge one's understanding of the differences in businesses).

The Owner/Authorized Agent of the Vehicle has requested Professional Drivers, its Driver/Agent, to transport the Owner/Authorized Agent's pet(s) name; \_\_\_\_\_ and \_\_\_\_\_

Professional Drivers and its Driver/Agent will make every effort to care for the pet(s) while being transported. The Driver/Agent will care for the pet(s) in a caring, loving manner, feeding the pet(s) and giving water to the pet(s) throughout the trip. Pet(s), with except of dogs\*, **MUST** be crated. All pet(s) need a collar, i.e. dogs and cats, must have appropriate vaccination tags and a leash for their collar. However, Professional Drivers and its Driver/Agent, assumes no responsibility whatsoever for injuries, sickness, disability or even in the event of sudden death, or other situations that may arise, to the pet(s) while being transported. In the event the pet(s) becomes ill during the trip, the Driver/Agent will take the precautionary measure to locate the closest Veterinarian's office that has boarding facilities to ensure the pet(s) receives proper care. If Veterinarian deems it necessary for the pet not to continue travelling, the pet(s) will be left at the Veterinarian's boarding facility. It is expressly understood the Owner/Authorized Agent is responsible for the authorization and payment of **ALL** matters arising from the pet(s) being taken to the Veterinarian. The Veterinarian will consult with the Owner/Authorized Agent as to the best course of action as to whether Driver/Agent should remain with the pet, close to Veterinarian's facility, or to resume the trip. Should the Owner/Authorized Agent decide for the Driver/Agent to remain with the pet(s), the standard waiting fees\*\* will be charged. If for any reason the Owner/Authorized Agent does not want Professional Drivers and our Driver/Agent to complete the trip, the Owner/Authorized Agent will be responsible for paying Professional Drivers the entire contracted price plus all incurred expenses plus including transportation, food, overnight accommodations and ground transportation costs associated with the return of our Driver/Agent to his/her home base. The Owner/Authorized Agent will hold Professional Drivers harmless for any event relating to the pet(s).

\*Unfortunately, we are unable to transport any form of Pitbull breed of dogs.

\*\* Please see your 'Contract To Provide Services' for standard waiting fees.

The Owner/Authorized Agent warrants and represents the pet(s) are neither dangerous nor aggressive towards humans, property or other animals. The Owner/Authorized Agent is completely financially responsible for the authorization and payment for any damage to property, humans or other animals caused by pet(s) behavior or illness being transported and promptly pay all damages on demand including all hotel fees assessed and deemed appropriate by the hotel for overnight accommodations. The Owner/Authorized Agent shall indemnify and hold Professional Drivers and its Driver/Agent from any claim or loss resulting from such damage. In the event the pet(s) becomes aggressive during the trip, Professional Drivers reserves the right to place the pet(s) in a kennel or with a Veterinarian at the Owner/Authorized Agent's expense.

It shall be clearly understood, if the pet(s) escapes from the care and custody of the Driver/Agent, Professional Drivers and all its Driver/Agents, will be held harmless and not responsible for such occurrence. The Owner/Authorized Agent, in consideration of the agreement with Professional Drivers to transport the pet(s), hereby irrevocably and completely releases Professional Drivers and its Driver/Agent, officers, directors, employees, contractors and attorneys from all liability, claims, suits, demands and judgments of any kind, resulting from or in any way, connected with the transportation of the pet(s). This agreement shall be interpreted pursuant to the laws of the State of Texas and any dispute concerning it shall be resolved in the courts of the State of Texas.

This Addendum is used in conjunction with 'Contract To Provide Services' and all of the provisions outlined in said contract between the parties of the agreement.
